For such a purpose, they may need to hire a court reporter to ensure that a verbatim record of the proceedings is made, which includes the testimony and evidence upon which the appeal is to be based.

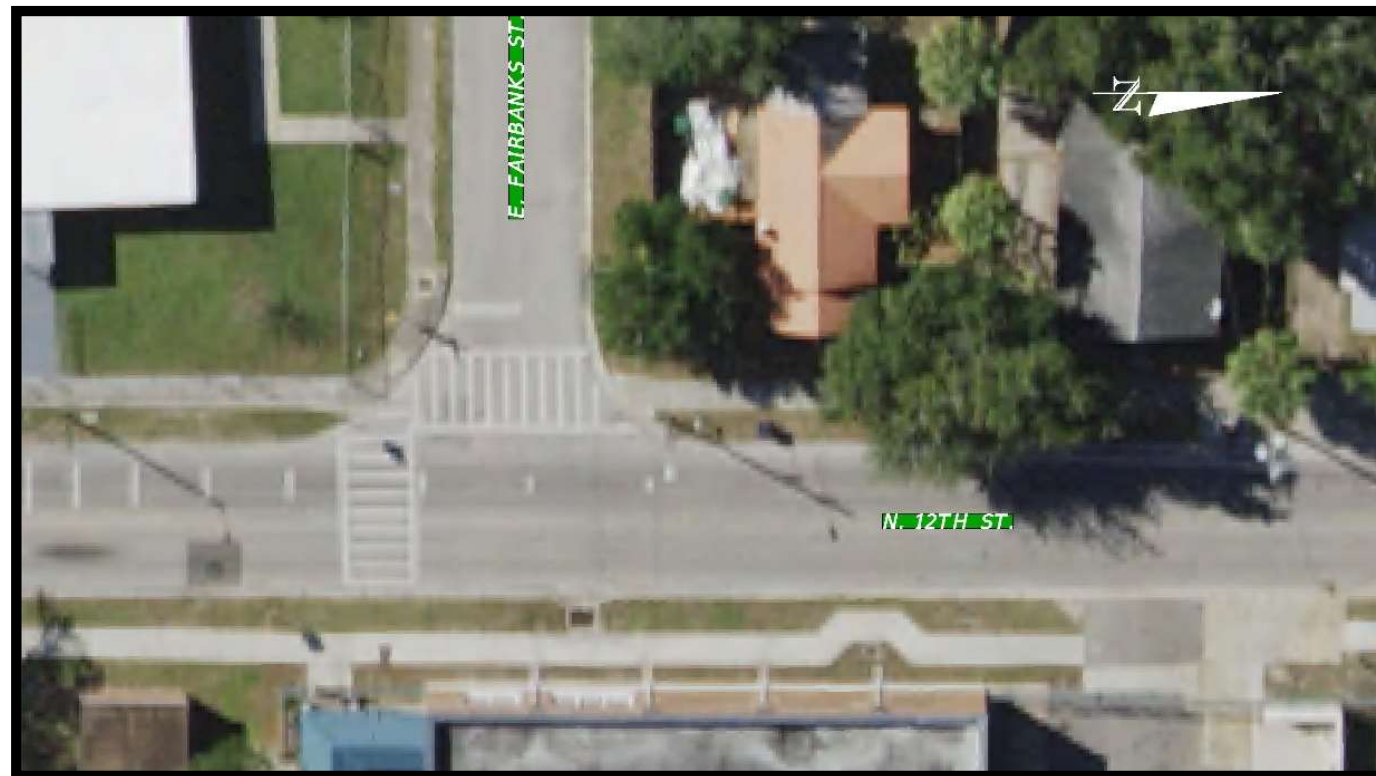

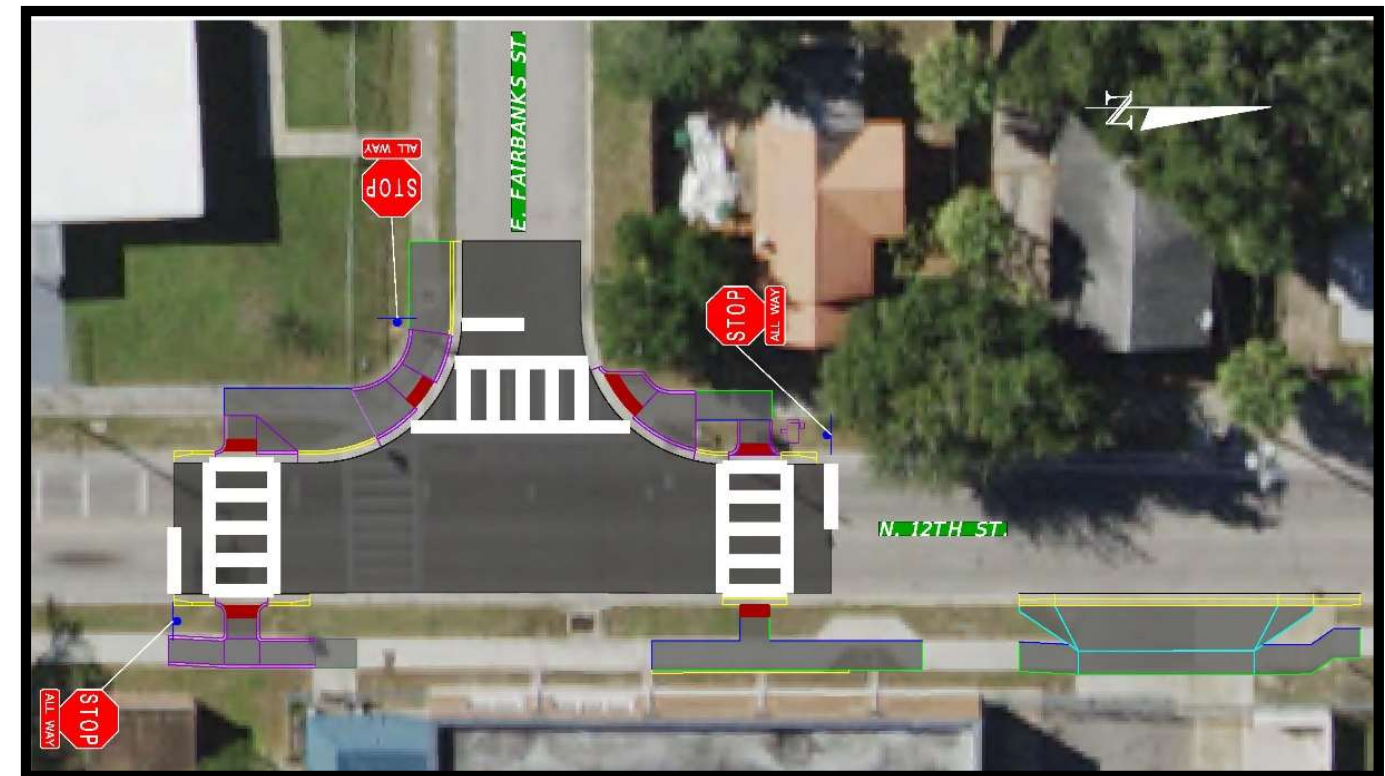

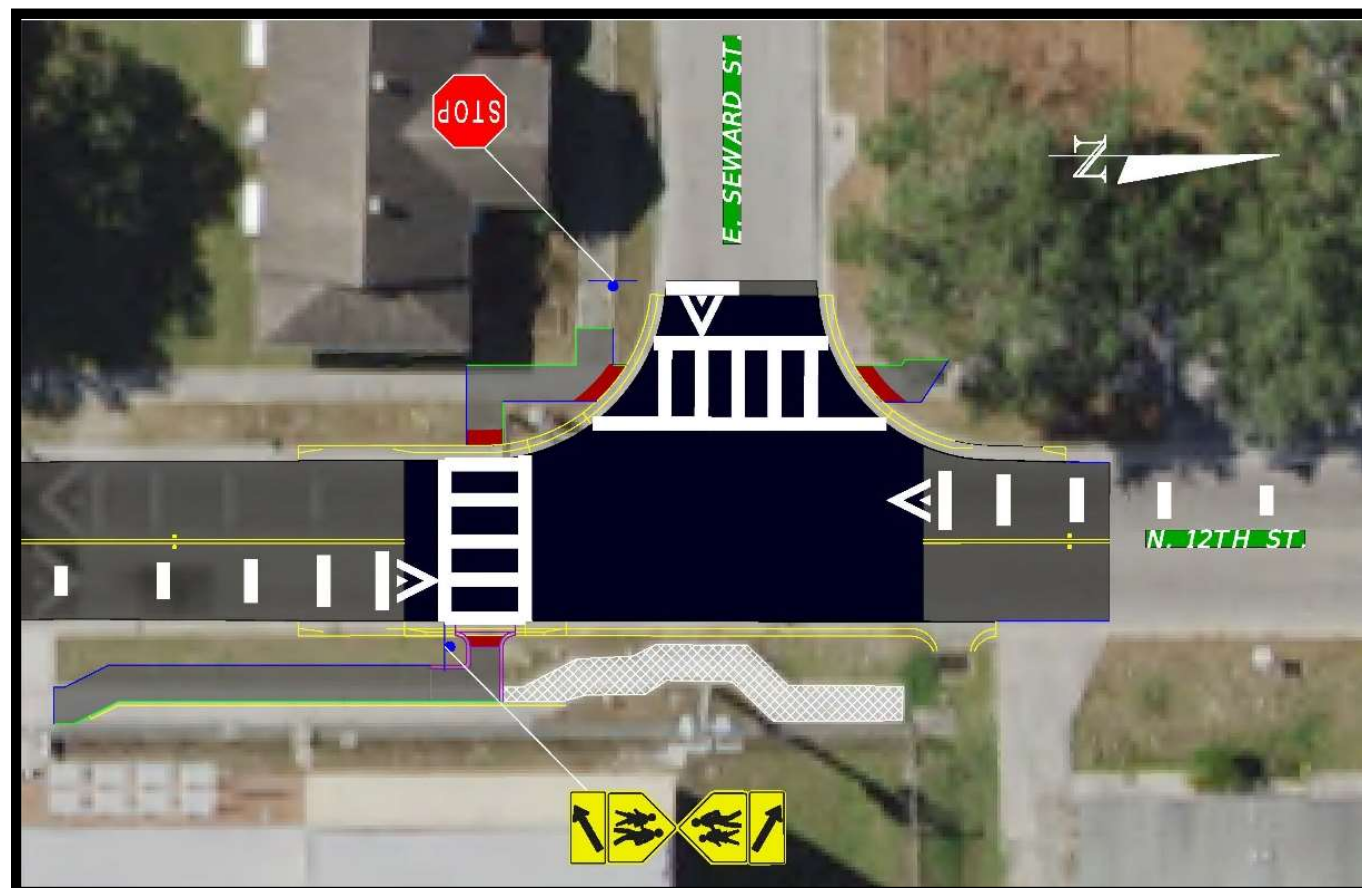

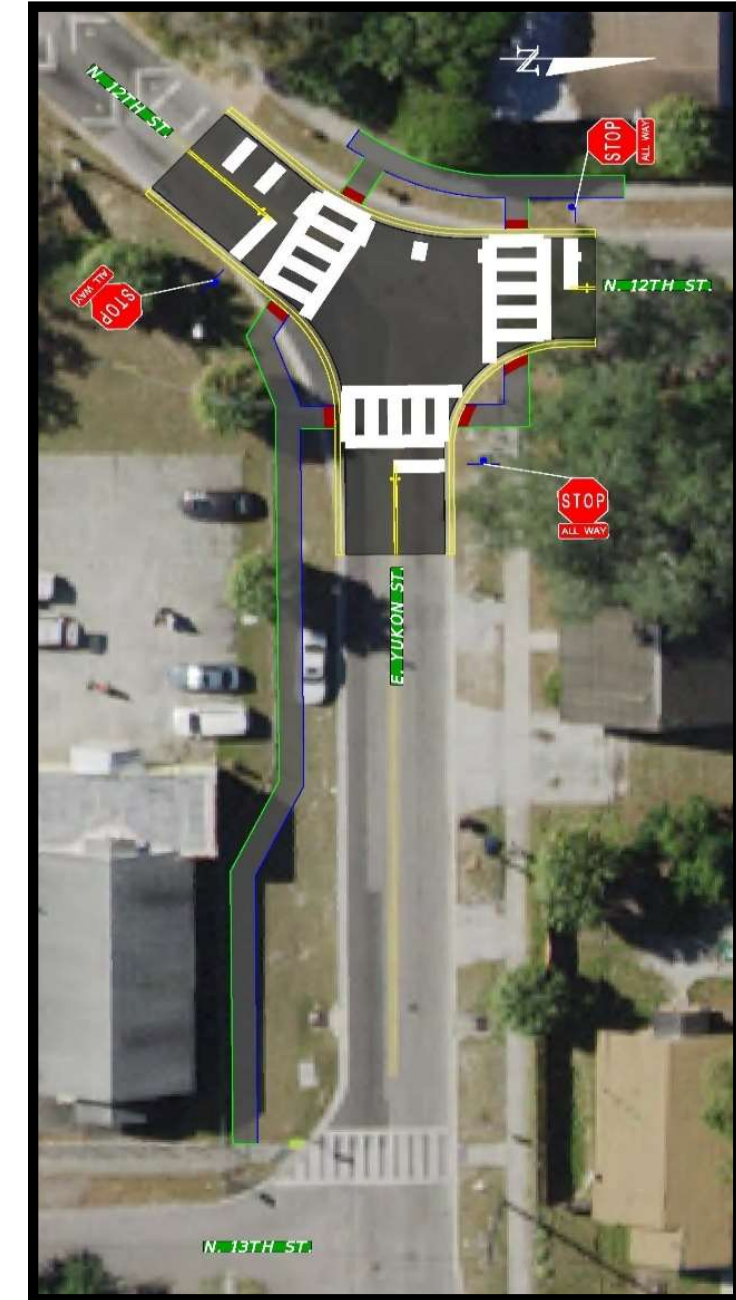
N. 12th St. at E. Yukon st.

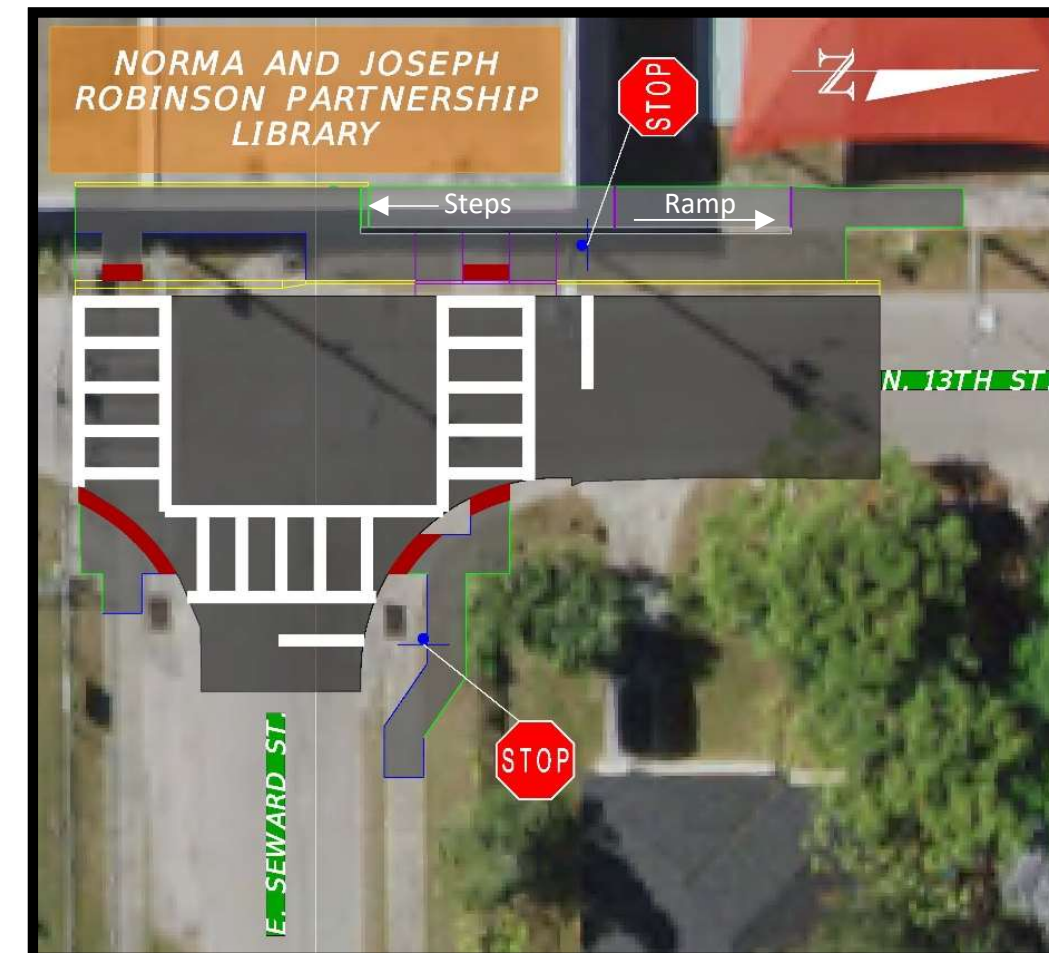

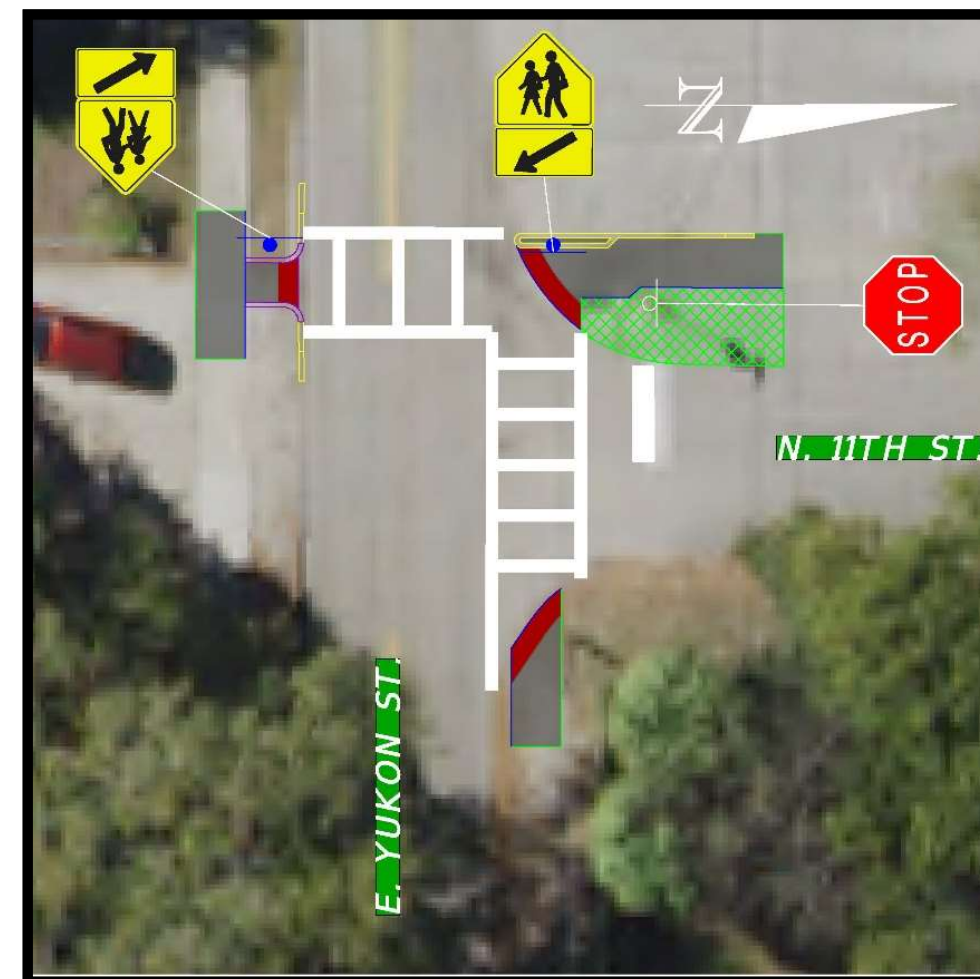

- Update Sidewalks and ADA Curb Ramps

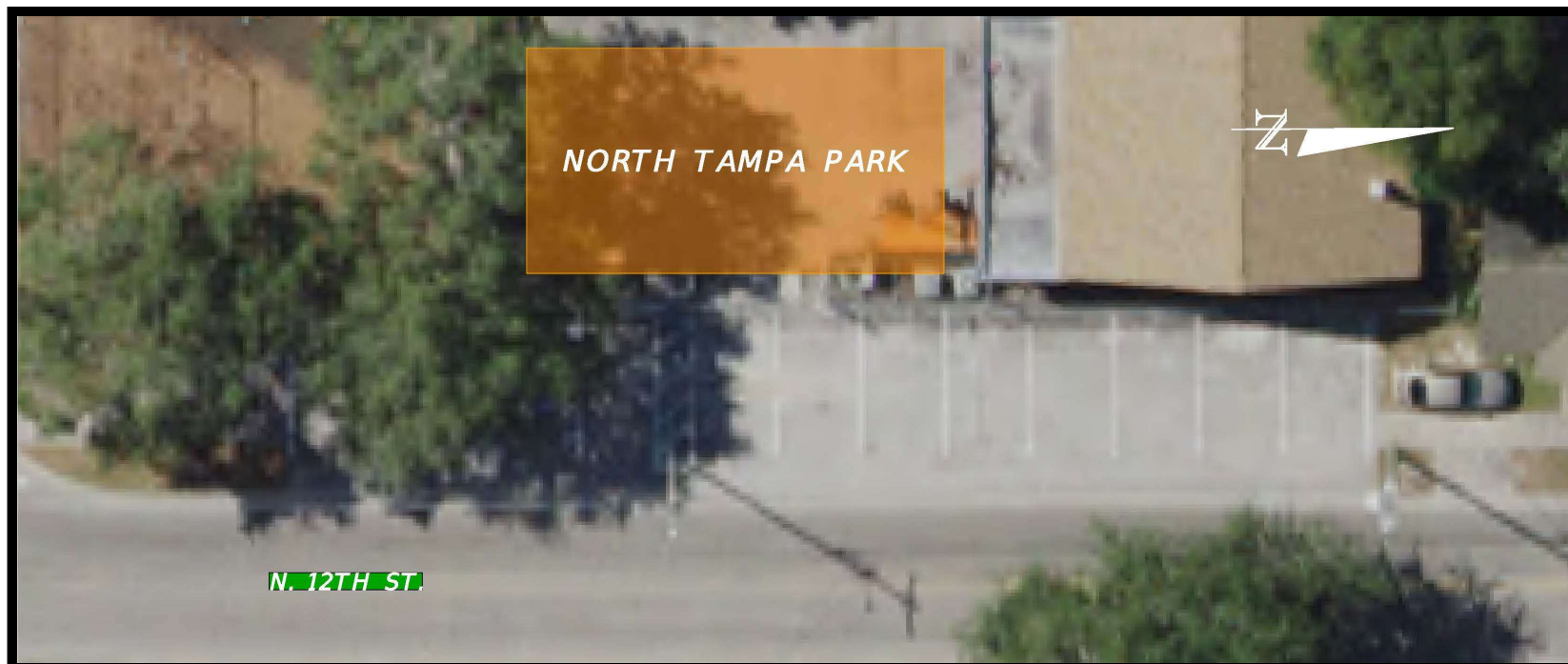

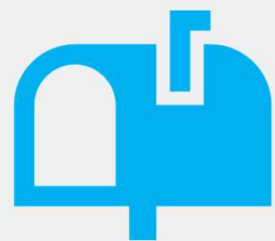
